I agree to hold harmless Avalon Meadows Equestrian Center, its employees, officers, and show grounds from any damage or injury that occurs to any horse or rider, including myself that I bring to the listed show date.

"Every entry at an affiliated event shall constitute an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, driver, rider and the horse shall be subject to the Bylaws and the Rules of the Association, the rules and regulations of the show, and that every horse, rider and/or driver is eligible as entered and that the owner and any of his representatives are bound by the Bylaws and Rules of the Maine Horse Association (MHA), the NEJA, the MEHJA, MECTA, Avalon Meadows Equestrian and the affiliated event, accept as final the decision of the Maine Horse Association, Inc., the NEHA, the MEHJA, MECTA, Avalon Meadows Equestrian or committees thereof in any question arising under said rules, and agree to hold the affiliated event, the MHA, the NEHA, MECTA, and the MEHJA, Avalon Meadows Equestrian, their officials, directors and employees, harmless for any action taken. The constitution or application of Maine Horse Association, Inc., rules is governed by the Laws of the State of Maine."
